<u>2023 Paving Program</u> – Pre-construction meeting was held with Youngblood Paving regarding the paving program. Youngblood plans to start preparations in mid-May.

GTRP Grant - Greenways, Trails and Recreation Program grant in the amount of \$250K is being submitted for Marmo Park Playground rehabilitation. MOTON by Ms. Donovan, second by Mr. Lenz to approve Res. 2023-03 for the GTRP grant. Borough matching share is \$37,500. Motion unanimously carried by roll call.

COMMITTEE REPORTS

BOROUGH PROPERTY - Abigail Donovan/David J. Lang

<u>Salt Shed</u> – Several quotes received for the proposed salt shed. Committee meeting will be held prior to the June 14 council meeting to determine size of the shed, asphalt surface size and recommendation to award the project.

<u>Cummins Power, Generator Service</u> - Pres. Yurkovich spoke with a manager at Cummins re the outrageous invoice submitted after a recent emergency callout when the power was recently out, the fire station doors did not operate. It was determined the missed parts should have been noted if the fire station garage doors had been tested during the last preventive maintenance appointment. Cummins will waive all travel expenses. Borough Property will research other companies who perform generator preventive maintenance to determine whether or not to stay with Cummins or go with another company. Ms. Donovan recommended staying with Cummins for the upcoming preventive maintenance check and making a determination thereafter.

<u>Retro Lights</u> – Chaz Lindell has completed the retro-fitting of LED lights at the borough building except for the lighting above the outdoor sign. A 20% savings in electricity has already been noted in the first month.

<u>Bulk Rock Salt Storage</u> – Ms. Donovan reported a letter was recently received from Cargill regarding storage of unpurchased bulk rock salt due to the mild winter. Emsworth has approximately 260 unused tons of salt to be purchased and delivered by end of the year. Pres. Yurkovich reminded council once the new salt building is installed, delivery of this tonnage would be scheduled. MOTION by Ms. Donovan, second by Mr. Lenz to participate in the Cargill Agreement through SHACOG for storage of unused bulk rock salt. Motion unanimously carried by roll call.
